

## **DECLARATION OF CONFORMITY RoHS / REACH AND DECLARATION OF ABSENCE OF ASBESTOS IN ITS OWN PRODUCTS**

By this declaration, the undersigned company DATEXEL S.r.l. guarantees that all of the devices of its own production are in compliance to the current existing rules with regard to environment safety and protection of the health of the involved operators.

### **Directive RoHS/ RoHS2 (Restriction of Hazardous Substances in Electrical and Electronic Equipment)**

Since the date of the entry into force of the European Directives on the restriction of the use of dangerous substances, DATEXEL S.r.l. has kept the conformity to the RoHS Directive (2002/95/EC) and to the successive revision RoHS2 (2011/65/EU) complying with the restrictions defined inside them and ensuring that all of the materials and the finishes of its own products do not exceed the acceptable levels imposed for the concentration of Cadmium, Mercury, Lead, hexavalent Chrome, Polybrominated biphenyls (PBB), polybrominated diphenyl Ether (PBDE). ### **Directive RoHS3**

DATEXEL S.r.l. certifies that its products are manufactured in compliance to the requirements of the Directive RoHS3 (2015/863/EU) that restricts the use of the following dangerous substances within the concentration limits reported in the list below:

- Lead (Pb): < 1000 ppm
- Mercury (Hg): < 100 ppm
- Cadmium (Cd): < 100 ppm
- hexavalent Chrome (Cr VI) < 1000 ppm
- Polybrominated biphenyls(PBB): < 1000 ppm
- Polybrominated diphenyl Ether (PBDE): < 1000 ppm
- Di-(2-ethylhexyl) phthalate (DEHP): < 1000 ppm
- Butyl benzyl phthalate (BBP): < 1000 ppm
- Dibutyl phthalate (DBP): < 1000 ppm
- Diisobutyl phthalate (DIBP): < 1000 ppm

Considering that the REACH and RoHS regulations with the respective lists of substances subjected to restrictions are continuously updated, DATEXEL S.r.l. will evaluate further revisions of the present declaration. Otherwise it is intended as confirmed what is declared.

### **Declaration of Conformity REACH (Registration, Evaluation, Authorisation, Restriction of Chemicals)**

DATEXEL S.r.l., in according with the regulations **REACH 1907/2006/EU, 2017/999/EU, 2017/1000/EU, 2018/2005/EU** and with the list of the dangerous substances recorded by the ECHA (European Chemicals Agency), with particular reference to the attachments XIV and XVII, declares that the products manufactured in its own factories don't release, in normal and reasonably predictable conditions of use, any dangerous substance neither for the human health nor for the environment. In any case, as potential downstream user of chemical substances, DATEXEL S.r.l. applies the measures for the management of the risks related to dangerous substances listed in the files about the data on safety (Safety Data Sheets) of its suppliers.

### **Absence of substances containing Asbestos**

DATEXEL S.r.l. declares that all of its products are free of substances containing Asbestos.
